PROTECTING OUR CHILDREN FROM **GUN VIOLENCE**



The League recently sponsored a community forum with a panel of resource people who are all working to reduce the threat from gun violence for children in this country. The audience was particularly interested in discussing how to most effectively communicate with elected officials. One speaker stressed repeated contacts; other responses were to look for natural connections (friends of friends, club/church membership, etc.), and definitely attend events such as coffee hours. Emily Durbin, Michigan leader of MOMS Demand Action, encouraged attendees to be aware of current legislation and to work to persuade lawmakers to support legislation that is keeping children safe. Sonya Lewis, M.D. and a member of Physicians for Prevention of Gun Violence & Suicide among

children and youth, spoke about the connection between suicide and guns. She stressed that gun violence is a public health issue and that strategies must be developed to keep children from accessing guns.

Scott Nichols, retired from the Michigan State Police, advocated for Emergency Restraining Protection Order (ERPO). ERPO is a tool to let family members have fire arms seized from a potential user. Contact your Michigan representative to encourage a committee hearing on House Bills 4706-4707.
